**HEREBY DECLARE AS FOLLOWS:**

1. I undertake to comply with the Articles of Association and/or the regulations of the KNVB, UEFA and/or FIFA and/or decisions of one or more of their bodies when carrying out my work and activities as a football agent. In this context, I confirm and expressly agree that by being registered as a football agent by the KNVB (in accordance with the KNVB Football Agents Regulations), I am bound by the Articles of Association and/or regulations of the KNVB, UEFA and FIFA and/or decisions of one or more of their bodies, and I fall under the jurisdiction of the bodies of the KNVB, including but not limited to the disciplinary bodies and the arbitration board.
2. I declare that I will not directly and/or indirectly oblige a player, (assistant) trainer-coach and/or club to be represented by myself or by another football agent in the negotiations regarding the realisation of:
  - a. employment contracts between (assistant) trainer-coaches and a Dutch club;
  - b. player contracts with a Dutch club; and/or
  - c. agreements regarding the transfer of players to a Dutch club,
 that do not have an international dimension and/or are not related to an international transfer or transaction within the meaning of the FIFA Football Agent Regulations.
3. I declare that I will refrain from using KNVB logos.
4. I declare that I will not directly and/or indirectly take part in and/or otherwise be involved in betting, gambling, lotteries and/or similar activities and/or transactions in connection with football matches. I am aware that I am therefore not permitted to have an active and/or passive interest in companies and/or other organisations that promote, mediate, arrange and/or carry out such activities and/or transactions.
5. I declare that I will provide, upon request, complete and correct information and statements, both oral and written, to a body of the administrative and/or judicial authority, the prosecutor, the Professional Football First Instance Body, the Amateur Football First Instance Body and the Women's Premier Division First Instance Body, or to another body designated by one of these bodies.
6. I give the KNVB permission to publish information about any sanctions imposed on me and/or to report this to FIFA.
7. I am aware and/or agree that this statement will be made available to the competent bodies of the KNVB.

8. I declare that I will immediately report any violations of the KNVB Football Agents Regulations and/or the FIFA Football Agent Regulations that I become aware of to the KNVB or FIFA respectively.

This statement is made by me in good faith and truthfully, based on the information and material that is available to me and which reasonably should have been available to me at the time of signature. I accept that the KNVB has the right to carry out all necessary checks to verify the information provided in this statement. I accept that I am obliged to inform the KNVB immediately if, after submission of this statement, the information provided above is no longer correct.
